2. Role of the Beneficiary

The BENEFICIARY has stated that it belongs to one of the following categories:

- A GSM Association signatory or a company acting on behalf of a GSM Association signatory;
- A GSM network operator's system supplier, manufacturer or subcontractor who supplies equipment containing the A5 algorithms;
- Manufacturers of GSM test equipment containing the A5 algorithms;
- Manufacturers of GSM system simulators containing the A5 algorithms;
- Manufacturers of MS containing the A5 algorithms.
- Manufacturers of GSM equipment authorised to receive A5 algorithm from the administrator

3. Role of the Provider

The PROVIDER is authorised to transfer the confidential information mentioned below to the BENEFICIARY in his role as:

- The GSM Association A5 test data administrator;
- A GSM Association signatory, or a company acting on behalf of a GSM association signatory, who received the confidential information from the A5 Test Data administrator;
- A supplier or manufacturer of GSM equipment as described above who received the confidential information from a GSM Association signatory.

4. Obligations

The PROVIDER undertakes:

- 4.1. to give to the BENEFICIARY [] registered copy of the Test Data for the GSM Cipher Algorithm A5 provided by the GSM Association numbered [to] ("the Test Data"), and
- 4.2. to forward a copy of all signed CONFIDENTIALITY AND RESTRICTED USAGE UNDERTAKINGs known to the PROVIDER and the GSM Association A5 test data administrator:

The BENEFICIARY undertakes:

- 4.3. to keep strictly confidential all information in the Test Data here above mentioned and all related communication, written or verbal, which has been associated with that information including algorithms, (the "CONFIDENTIAL INFORMATION");
- 4.4. not to make any copies or photocopies of the CONFIDENTIAL INFORMATION provided, even for internal usage;
- 4.5. not to disclose the CONFIDENTIAL INFORMATION to any party without prior and explicit authorisation in writing by the PROVIDER;
- 4.6. to take all measures which are necessary to avoid that its personnel disclose all or part of the CONFIDENTIAL INFORMATION to third parties, without prior explicit authorisation in writing by the PROVIDER;
- 4.7. to use the CONFIDENTIAL INFORMATION for the sole purpose to procure, design, manufacture or supply equipment for signaling and data privacy in the GSM system that require such test data; all other usage of the CONFIDENTIAL INFORMATION is prohibited;
- 4.8. to grant licenses on fair, reasonable and non-discriminatory terms and conditions, under all ESSENTIAL patents resulting from the implementation of the CONFIDENTIAL INFORMATION, proposed by GSM, for use, sale and or manufacture of equipment in countries represented in the GSM Association.
 [ESSENTIAL patent shall mean a patent which is implemented by the equipment or operation thereof, where it is not technically possible to make, sell or operate equipment which complies with the specification of the A5 algorithms provided by GSM without infringing such a patent.]
- 4.9. not to do any act or thing which would in any way affect, conflict or contradict with any Intellectual Property Rights ("IPR") owned or maintained in the CONFIDENTIAL INFORMATION by the PROVIDER and to in no way challenge any such ownership of the IPR in the CONFIDENTIAL INFORMATION by the PROVIDER;
- 4.10. to make best efforts in the design of equipment authorised by the present undertaking, in order that the CONFIDENTIAL INFORMATION cannot be used for applications other than those explicitly defined in the ETSI/GSM standard (GSM technical specification 03.20 and 02.09);

4.11. not to sub-contract any part of the design and manufacturing of equipment authorised by the present undertaking to any entity who has not forwarded a signed CONFIDENTIALITY AND RESTRICTED USAGE UNDERTAKING to the PROVIDER.

If, after eight years from the date of undertaking, the BENEFICIARY has not used the CONFIDENTIAL INFORMATION, or if he is no longer active in the business mentioned above, he shall return the written CONFIDENTIAL INFORMATION which he has received. The BENEFICIARY is not authorised to keep copies, notes or photocopies of or relating to the CONFIDENTIAL INFORMATION; THE BENEFICIARY is forbidden to make any further use of the CONFIDENTIAL INFORMATION. The BENEFICIARY is bound by the clauses of this undertaking, until the totality of the CONFIDENTIAL INFORMATION is in the public domain.

The obligations of confidentiality herein shall not apply to any INFORMATION, which the BENEFICIARY can show:

- Was known to the BENEFICIARY before such INFORMATION was received; or
- Is in or subsequently comes into (other than by breach of this obligations hereunder) the public domain; or
- Is received by the BENEFICIARY without restriction on disclosure or use from a third party, which the BENEFICIARY reasonable believes is free to make such disclosure on such terms; or
- Is developed or discovered independently without reference to the INFORMATION disclosed under this undertaking.

Evidence of being a BENEFICIARY shall be given to the PROVIDER by providing a copy of this undertaking duly signed and certified by the BENEFICIARY and the PROVIDER. This undertaking shall be construed and interpreted in accordance with the laws of Ireland.
