Welcome, Agenda & Antitrust reminder - Eszter, GSMA

Attendees were welcomed to the meeting and reminded that the GSMA Antitrust policy applies to this meeting. The GSMA position regarding the US Entity List was also explained.

Remote ID review - Barbara, GSMA

Barbara introduced the EASA timeline, going through the outcomes which will lead to the registration of UAS operators and drones becoming mandatory in June 2020.

Barbara has summarized the problem statement which is that the mobile networks are suitable to fulfil the regulation requirements. The members have been agreed on that a public document would fit best for the purpose to showcase the cellular solution benefits for remote identification. The members also agreed on that they will include in the document the how and why as well as highlight some already existing remote ID study results like SUSI, ASTM etc.

The members have been agreed on that also a landscaping part is needed, which would be able to decide the format of the document later on. The members are also looking to develop potentially a summary part to highlight the difference between the broadcast and cellular network solutions. The document also will include the already existing demonstrations.

The members have been agreed on that the next steps will be to fill with content the document skeleton. Following on that a new technical meeting needed to discuss further the content. The remote ID subgroup will be working on the document with the aim to publish it before the MWC Barcelona event 2020.
