1. GSMA Antitrust Policy and Agenda

2. K – Connectivity Models (Ericsson)

Bart presented CR0001R2 going through the open comments

- A change to section 1.2 was agreed as an action on the editor, resulting in a revision.
- No objections were raised against including CR0001R3 in the baseline CR for OPG.02 v2.0

3. Topic B – Exposure of NW Operator Capabilities Beyond Edge Resources (MobileEdgeX)

4. Topics A,E,N - Seamless Service Continuity (Capgemini)
