Welcome, Agenda & Antitrust reminder – Eszter, GSMA

Attendees were welcomed to the meeting and reminded that the GSMA Antitrust policy applies to this meeting. The GSMA position regarding the US Entity List was also explained.

Counter Drone Solution - Neil Brady, BT

Regulatory update – Marina Solin

Marina firstly provided an update on the JARUS paper 'Cellular connectivity for drones'. The final draft and is due to be released for an internal JARUS consultation. There was a JARUS brainstorming workshop on the 1st October at GSMA offices to discuss connectivity requirements in context of SORA.

Members have been encouraged to provide input on the upcoming U-Space (EU) regulation consultation.

The Draft European report that proposes restrictions on mobile bands was introduced to the members. Oliver has asked the members to assess the current proposed regulatory measures in the draft report with their spectrum experts and if needed get involved in the process. They may also contact Eszter to find out who their representative is on the GSMA's FREQ working group which deals with European spectrum issues if they wish to raise the issue there.

Remote ID Update – Barbara Pareglio

Barbara introduced the EASA timeline, going through the outcomes which will lead to the registration of UAS operators and drones becoming mandatory in June 2020.

Barbara asked if there are any interested members wanting to join the remote ID subgroup with GSMA. The first step would be to define the problem statement, the scope of the task force and the outcome as well as define how to deliver it.

Graham introduced the Connected Skies events planned for MWC Barcelona.
