3. MWC Barcelona Release Planning

Mark updated on the planning for the MWC Barcelona release.

As per OPG meeting, release has been delayed by approx. 4 weeks. New dates were presented.

OPAG review now extends to 2nd February before OPG review until 21st Feb and ISAG approvals by 22nd March

4. UNI update

Miguel presented the latest UNI document

OPAG_52_Doc_08_UserNetworkInterfaceAPIDefinition_v1.0. There had been a meeting to discuss on Monday 9th Jan but little attendance. Comments on the last version have however been incorporated. Tom comments on formatting and style have been accommodated. Comments from Samsung have also been taken into consideration and included in the latest version. No other comments outstanding.

Document was approved by the meeting and will now be released for OPG review according to latest timeline.

5. EWBI update

Deepak introduced OPAG_52_Doc_06_Block-A_OPG.04 v1.2.1, proposing the changes to OPG.04 to cover the enhancements proposed in for the MWC Barcelona release of the EWBI. Only comments received so far were from Tom. These have been included. Several new comments were made in the meeting:

- Deepak noted that the YAML is not quite finished
- Mark requested that a developer ID is included in the EW encapsulation and transaction ID to allow traceability and billing
- Eddie asked if Developer ID is needed in Northbound interface? No- this comes from the OAuth request.
- Consent will be answered in CAMARA
- Connect ID was clarified, it will be shared back to leading OP where a request has a duration of validity e.g. duration of session. It will also have an expiry time.
- Deepak stated that document and YAML is correct as of today but interface understanding is progressing in the short term due to learnings in an ongoing activity.

Meeting Agreed that there is a lot to review. Deepak will organise meetings on Mondays 2-3pm uk time for the next 3 weeks to review and progress towards approval. Presentations in OPAG will be progress updates rather than review until final review. Planned 2nd Feb.

6. 3GPP SA LS on Network federation interface for Telco edge consideration

Niranth was not on the call. Meeting agreed that discussion will be postponed until OPAG#53

7. SBI-NR update

Alex provided a verbal update on the status of the SBI-NR activities. Focus has moved for this activity to focus on how to obtain a network Identifier that needs to be anonymised. TEF uses a static mapping to achieve this from external IP. Other methods are available. Aim to examine options than document this on SBI-NR Alex will present the draft CR for SBI-NR and the TEF solution in OPAG #53

Milan shared a CAMARA Update:

- CAMARA - Commonalities API meeting is today
- CAMARA is recognised in industry more and more.
- Understanding that CAMARA is focussed on End customer and rather than network.
