
Functional Architecture & Technical Requirements



- OIDC: OpenID Connect protocol based on Oauth 2.0
- OTA: Over The Air (Includes OTA Gateway)
- OTP: One Time Password
- ID GW: Identity Gateway is the connector between OIDC request coming from service providers and the Mobile Connect MNO platform
- OP-MNO: Operation Mobile Network Operators
 - Connector Mobile Connect users to MNOs lifecycle notification system
- MSSP: Mobile Signature Service Provider (ETSI 102.204)

Generic technical requirements
