Terms and Conditions for access to the InfoCentre² incorporated within this document.

A member of your organisation must be nominated to deal with the administration of your company details on the InfoCentre². This person will be known as the Member Information Manager (MIM).

Sections 1 - 3 of this InfoCentre2 Connection Guide must be read, completed and signed by your Member Information Manager. Please return the completed Section 2 and Section 3 to membership@gsma.com

Section 1 Terms and Conditions

GENERAL

Welcome to the GSMA InfoCentre² available at <https://InfoCentre2.gsma.com> (the, "InfoCentre²"). The InfoCentre² is provided by the GSMA whose head office is at second floor, The Walbrook, 25 Walbrook, London, EC4N 8AF ("GSMA", "us", "we" or "our", for short). "You" and "your" means (i) you as a registered user who is authorised to access InfoCentre² in accordance with these terms and conditions ("Terms of Use"); and (ii) unless expressly stated otherwise, the GSMA Member Organisation on whose behalf you are accessing and using the InfoCentre² (as set out and defined as such in the registration confirmation).

DEFINITIONS

In this agreement the following words and expressions shall have the following meaning:

"Association"	Shall mean the GSMA.
"Access"	Shall mean access to the InfoCentre ² via electronic means.
"Materials"	Shall mean all documentation and information contained in the InfoCentre ² , including but not limited to Permanent Reference Documents, Member information, position papers and maps.
"InfoCentre ² "	Shall mean a centralised information database or library, containing Documentation/Information, managed by the Association in London.
"InfoCentre ² Administrator"	shall mean an employee, officer or agent of the Association who has been duly appointed to manage the administration of the InfoCentre ²
"GSMA Member Organisation"	shall mean a Full, Associate, Rapporteur or Parent Company Member as defined in the GSMA Articles of Association
"Member Information Manager, MIM"	Shall mean the person named below who is duly authorised by the Member to represent it and act on its behalf for the purposes of this agreement. "Nominated User" is a person duly appointed by the Member Information Manager and registered to access InfoCentre ² on behalf of the GSMA Member Organisation. "Registered User" is either a MIM or a Nominated User.
"Retrieved "or "Retrieval"	Shall include Access to Documentation/Information which thereafter is received, viewed or stored in any format.

APPOINTMENT OF MEMBER INFORMATION MANAGER (MIM)

Before you may be granted access to the InfoCentre², the principal contact at a GSMA Member Organisation who may apply to use InfoCentre² must register as the initial registered user of the GSMA Member Organisation. This person is known as the "**Member Information Manager**" (or "**MIM**"). The MIM must be an employee of the GSMA Member Organisation approved by an officer of the GSMA Member Organisation.

Qualification of a GSMA Member Organisation and the corresponding level of access to which that organisation is entitled, shall be determined by the GSMA's Articles of Association and associated GSMA documents (as amended from time to time).

When a MIM registers, the MIM must submit the full registered name and address of the GSMA Member Organisation. Once the MIM's registration is confirmed, the registration confirmation shall include the MIM username and password to access the InfoCentre². Only the MIM may use the MIM username and password to access and use the InfoCentre².

InfoCentre² Connection Guide RESTRICTED

In order to register as a MIM and allow anyone from the relevant GSMA Member Organisation to access the InfoCentre² under the Terms of Use (as defined in Section 1 Terms and Conditions), please accept the Terms of Use by completing Section 2 and Section 3 and returning completed, signed and dated Sections 2 and 3 in PDF format to GSMA membership via email: membership@gsma.com.

Alternatively, if you are already an InfoCentre² registered user, you may search and download the latest MIM registration details (IST Guide Form). On completion this needs to be returned to GSMA Member Services by email to membership@gsma.com. On receipt, this will be processed and the MIM account set up.

Each GSMA Member Organisation wishing to use the Infocentre2 must have a duly appointed MIM at all times. In case the appointed MIM is not available, has 'Opted Out' of receiving email correspondence from GSMA, or has been deregistered, the GSMA may elect to use the Deputy MIM (defined in Section 3) as the recipient(s) of email correspondence. If the Deputy MIM is not available, the GSMA may contact any of the GSMA Member Organisation's registered users in order to administer, support and maintain the use of InfoCentre².

NOMINATED USERS

Once the MIM has received a registration confirmation email and followed the activation instructions to login, the MIM may then nominate other employees within the same organisation or company group, who can register to access InfoCentre² on behalf of the GSMA Member Organisation ("**Nominated Users**"). Nominated Users may only be granted access to InfoCentre² to the extent that they need to have access to perform their work for the GSMA Member Organisation or the GSMA.

To register, each Nominated User must request an InfoCentre² account via the main InfoCentre² home page. On submission this request will be sent to the relevant MIM who would validate and approve the registration.

The InfoCentre² would then generate automated instructions that will be sent to the Nominated User's email address with instructions to set up their password and to Login to InfoCentre².

MIM OBLIGATIONS AND WARRANTIES

The MIM represents and warrants that as an employee of the GSMA Member Organisation he or she has been duly authorised to act on behalf of the GSMA Member Organisation for the purposes of this Agreement.

The MIM undertakes to act as the official point of contact between the GSMA Member Organisation and the InfoCentre². The MIM has the responsibility to ensure that all obligations imposed by the GSMA with regard to access to and use of the InfoCentre² in accordance with the terms of this Agreement are met.

In the event that the MIM is absent for whatever reason, the MIM shall ensure that a replacement is duly authorised to act and shall notify GSMA Member Services by fax or e-mail to [membership@gsm.org] of the name of the replacement.

If the MIM ceases to be an employee of the GSMA Member Organisation or is not in a position to continue to act as MIM for whatever reason, the MIM shall (or will make prior arrangements to ensure that a suitable representative of his or her GSMA Member Organisation shall) immediately so notify "GSMA Member Services" by email to membership@gsma.com.

A MIM may not disclose his or her MIM username or password to anyone else and must keep the same strictly confidential and secure and protected against unauthorised access (and, in so doing, but without prejudice, shall implement and operate such technical and operational measures so as to keep as secure as its own sensitive confidential information and shall procure that each Nominated User (as defined above) shall observe the same strict confidentiality and security provisions described above).

IMPORTANT: The GSMA Member Organisation, represented by the MIM, shall be responsible for any failure by a Nominated User to fail to keep his or her username or password secure and/or for a breach by any Nominated User of the terms of this Agreement.

The MIM shall maintain a list of Nominated Users within the InfoCentre². The list shall contain the name of the person, their position within the GSMA Member Organisation or group, and their phone and fax number. The MIM shall keep the list up to date at all times. In addition, the MIM shall immediately notify GSMA Member Services if any employee's name is removed from the list for whatever reason, in particular if such person ceases to be an employee of the GSMA Member Organisation or group.

DISTRIBUTION OF DOCUMENTATION/INFORMATION FROM THE INFOCENTRE²

MIMs and Nominated Users (together: "**Registered Users**") may from time to time, be requested by the GSMA or a duly authorised employee or officer of the GSMA Member Organisation, to distribute to employees of the same GSMA Member Organisation, certain Materials from the InfoCentre². In accordance with the GSMA Regulations certain Materials may be confidential. Such confidential Materials must only be distributed to those employees that need to know for the purposes of their work for the GSMA Member Organisation or the GSMA.

ACCEPTANCE OF AGREEMENT

USE OF MAILING LISTS AND OTHER INFORMATION
